1. Year End Summary – Bob was not present
2. Budget Review – Beth presented the revised budget, based on input from the January meeting. There was a motion to approve the budget – it was seconded and approved with 16 votes in favor and 2 abstain.
3. If teams use the club’s tax ID for their bank account or to accept donations, their financial statement should be part of the club’s accounting.

President’s Report

1. Phone number for Club – BG needs to get a new phone number for the club. Chris gets a lot of calls requesting info, especially this time of year. In the mean time, she should refer callers to 342 8447.
2. Tape Recorder for meetings -- it was decided that we do not need to record meetings. The motion to not purchase a tape recorder was seconded and approved.

Business

1. Teams for Tournaments – we started talking about teams being DI or DIII and it was decided we needed to know who our 2009 coaches are. There was a motion to approve the list from the January meeting It was seconded and approved. Rob will work with Pete Hall and Scott Hodgkinson to decide who the head coach is for the U10 boys team. Rob is looking to put out a flyer and/or a blurb in the Chico ER to recruit coaches. There was a discussion on the qualifications for head and assistant coaches. Respectively, the license requirements are E/D and F. Beth will send Rob the blurb we’ve used in the past for his review and her submission to the Chico ER Sidelines.
Bruce said that DIII is growing and younger teams are going to US Club soccer. There is nothing in DVI for DI for the U10, U11, U12 age groups. Bigger Clubs have their “B” teams play CYSA.

 We need to decide how/if we are dual registering
 Teri Briggs brought up the need to define our vision for the Club and that we need to provide kids with the most competitive playing opportunities now, because if they don't get it when they are in grammar/middle school, it's almost too late in high school
